1. Review and complete Sections I and II of the 2020 Licensed Behavior Analyst Renewal Form. Update all new contact information. **Renewal Application is not valid without behavior analyst's initials.**
2. Return this renewal application and the current renewal fee of **\$400.00** in the form of a **certified check or money order**, by mail to: **LBAB, 4334 South Sherwood Forest Blvd., Suite C-150, Baton Rouge, Louisiana 70816** or use **online payment w/convenience fee and follow instructions for submitting by email.**
3. Renewals may require 1-2 weeks to process. Please submit renewal form and payment no later than December 15, 2019 to avoid delays in processing your renewal.

**Noncompliance:**

1. Noncompliance includes, in part, incomplete forms, unsigned forms, failure to file all of the required renewal forms, non-payment of fee in required form by December 31<sup>st</sup>, or failure to postmark the renewal package by December 31<sup>st</sup>.
2. If your license is not renewed by the end of December, the license will be regarded as lapsed effective January 1<sup>st</sup>. An individual shall not practice applied behavior analysis in Louisiana while the license is lapsed.
3. If your license lapses, all of your line technicians must immediately cease and desist all work with your clients.
4. A lapsed license may be reinstated, at the approval of the Board, if all applicable requirements have been met, along with payment of the renewal fee and a late filing fee of \$50.00.

**Continuing Education: 2019 is NOT a reporting year.**

1. Please note continuing education hours are required to be reported during the 2020 renewal period. (NEXT RENEWAL)
2. **Licenses issued in 2018 or before** – thirty-two (32) credits of continuing professional development, with four (4) hours in Ethics, will be required for Licensed Behavior Analysts.
3. **Licenses issued in 2019** - sixteen (16) credits of continuing professional development, with two (2) hours in Ethics, will be required for Licensed Behavior Analysts.
4. **Licenses issued in 2020** – no hours need to be reported until end of 2022. In 2022 thirty-two (32) credits of continued professional development, with four (4) hours in Ethics will be required.
