## VOLUNTARY SURRENDER OF LICENSE

WHEREAS, KRISTEN NOBLES ("MS. NOBLES") is a Licensed Behavior Analyst ("LBA") and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1101, et seq.), the Ethical Standards for Behavior Analysts (LAC 46:LX § 1001, et seq.) and the rules regarding disciplinary proceedings (LAC 46:VIII § 601, et seq.);

WHEREAS, on or about March 1, 2019, the Louisiana Behavior Analyst Board, ("LBAB") based upon a complaint received, and for reasons contained in the Order of Summary Suspension, summarily suspended LBA license number 157 issued to KRISTEN NOBLES pending an administrative hearing scheduled for March 11, 2019;

WHEREAS, on March 11, 2019, an administrative hearing was held before the LBAB regarding the suspension of MS. NOBLES' license;

WHEREAS, on June 18, 2019, a Findings of Fact and Conclusion of Law for Order of Summary Suspension was issued by the LBAB, wherein the LBAB, pursuant to the hearing of March 11, 2019, ordered the summary suspension of the LBA license of MS. NOBLES effective March 1, 2019;

WHEREAS, the respondent, KRISTEN NOBLES, has indicated her desire to voluntarily surrender her license with the LBAB, particularly LBA License No. L-157, in lieu of further and the last line in the line proceedings;

WHEREAS, the respondent, KRISTEN NOBLES, LBA, acknowledges that the following will result due to her voluntary surrender of her LBA license:

1. A report of this Voluntary Surrender of License and the conditions under which the license was surrendered shall be submitted to the National Practitioners Data Bank ("NPDB").

- 2. Public notification of this Voluntary Surrender of License by posting a copy of this Voluntary Surrender of License on the LBAB website.
- 3. A two (2) year waiting period before MS. NOBLES will be eligible to apply for reinstatement with the LBAB.
- 4. In the event that MS. NOBLES files a reapplication, a request for reinstatement as an LBA or a request for any other credential issued by the LBAB, MS. NOBLES shall be subject to prosecution of the pending disciplinary action (Complaint 2019-001C) if her reapplication, reinstatement or request for credential is granted. MS. NOBLES waives any defenses she has regarding the timeliness of the prosecution of the pending disciplinary action and/or prescription. Ms. Nobles shall not provide behavioral analysis services, in any capacity, prior to the completion of the disciplinary proceedings against her. Ms. Nobles must pay all expenses, fines and fees, and serve any discipline, if any, as ordered by the LBAB in association with the pending disciplinary action, before she may provide behavioral analysis services.

WHEREAS, based upon the above, KRISTEN NOBLES, LBA, surrenders her license held with the LBAB, particularly LBA License No. L-157.
