VOLUNTARY SURRENDER OF LICENSE

WHEREAS, KENNETH MACURIK (“DR. MACURIK”) is a Licensed Behavior Analyst (“LBA”) and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1101, et seq.), the Ethical Standards for Behavior Analysts (LAC 46:LX § 1001, et seq.) and the rules regarding disciplinary proceedings (LAC 46:VIII § 601, et seq.);

WHEREAS, in January, 2019, the Louisiana Behavior Analyst Board, (“LBAB”) received information regarding DR. MACURIK concerning a potential dual relationship with his Registered Line Technician, and certain representations made by his Registered Line Technician regarding her the scope of her work;

WHEREAS, by letter dated April 1, 2019, the LBAB notified DR. MACURIK of the Board-initiated complaint filed, provided DR. MACURIK with a summary of the nature of the complaint, and requested that DR. MACURIK, within thirty (30) days, provide a statement giving his review of the circumstances, which are the subject of the of the complaint;

WHEREAS, by letter dated April 26, 2019, DR. MACURIK submitted a response to the complaints, denying any wrongdoing;

WHEREAS, the respondent, KENNETH MACURIK, has indicated his desire to voluntarily surrender his license with the LBAB, particularly LBA License No. L-113;

WHEREAS, the respondent, KENNETH MACURIK, LBA, acknowledges that the following will result due to his voluntary surrender of his LBA license:

1. A report of this Voluntary Surrender of License and the conditions under which the license was surrendered shall be submitted to the National Practitioners Data Bank ("NPDB").
2. Public notification of this Voluntary Surrender of License by posting a copy of this Voluntary Surrender of License on the LBAB website.
3. A two (2) year waiting period before DR. MACURIK will be eligible to apply for reinstatement with the LBAB.
4. DR. MACURIK will be subject to prosecution of the pending disciplinary action at the time of reapplication or request for reinstatement as a LBA or upon application for any other credential issued by the LBAB, as determined by the LBAB.

WHEREAS, based upon the above, KENNETH MACURIK, LBAB, surrenders his license held with the LBAB, particularly LBA License No. L-113.

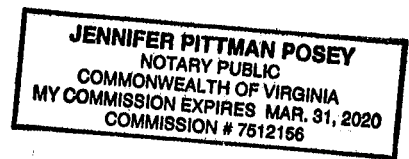




ORDER




