VOLUNTARY SURRENDER OF LICENSE

WHEREAS, JUSTIN DAIGLE (“MR. DAIGLE”) is a Licensed Behavior Analyst (“LBA”) and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1101, et seq.), the Ethical Standards for Behavior Analysts (LAC 46:LX § 1001, et seq.) and the rules regarding disciplinary proceedings (LAC 46:VIII § 601, et seq.);

WHEREAS, on or about October 27, 2017, the Louisiana Behavior Analyst Board, (“LBAB”) received information regarding MR. DAIGLE concerning personal conduct which may violate Section 1.05(F) of the Professional and Ethical Compliance Code for Behavior Analysts;

WHEREAS, by letter dated November 16, 2017, the LBAB notified MR. DAIGLE of the complaint filed, provided MR. DAIGLE with a summary of the nature of the complaint, and requested that MR. DAIGLE, within thirty (30) days, provide a statement giving his review of the circumstances, which are the subject of the of the complaint;


WHEREAS, by letter dated December 14, 2017, MR. DAIGLE submitted a response to the complaints;

WHEREAS, the respondent, JUSTIN DAIGLE, has indicated his desire to voluntarily surrender his license with the LBAB, particularly LBA License No. L-009;

WHEREAS, the respondent, JUSTIN DAIGLE, LBA, acknowledges that the following will result due to his voluntary surrender of his LBA license:

1. A report of this Voluntary Surrender of License and the conditions under which the license was surrendered shall be submitted to the National Practitioners Data Bank ("NPDB").
2. Public notification of this Voluntary Surrender of License by posting a copy of this Voluntary Surrender of License on the LBAB website.
3. A two (2) year waiting period before MR. DAIGLE will be eligible to apply for reinstatement with the LBAB.
4. MR. DAIGLE will not be subject to prosecution of the pending disciplinary action at the time of reapplication or request for reinstatement as a LBA or upon application for any other credential issued by the LBAB in lieu of the proper execution of of this Voluntary Surrender of License.

WHEREAS, based upon the above, JUSTIN DAIGLE, LBAB, surrenders his license held with the LBAB, particularly LBA License No. L-009.
